Another appointment to the group of McGill key operating people at the Culver Bearing Plant was made Monday by Harold Fritz, Plant Manager.

Charles Ness will organize and serve as foreman of the Maintenance Department at Bearing Plant No. 2. Ness has been with McGill since February, 1965, having previously operated his own business for 15 years. He is a graduate of Coyne Electrical School of Chicago in Industrial Electronics. Ness plans to commute between Culver and North Judson where he lives with his wife, Doris, and three children.

Announced were several promotions in the Valparaiso Bearing and Electrical Plants. Larry J. Hofferth is the new Assistant Foreman of the Automatic Screw Machine Department where bearing rings are formed and cut off of steel tubing. Hofferth joined McGill in 1958 in the Shipping Department and moved up to an automatic machine operator in 1959. The Chamber of Commerce met Monday noon, June 13, for luncheon at The Culver Inn.

Chamber President Dr. Joseph Howard introduced a group of Indiana State Police who were attending the Scuba Diving Training School at the Academy. Included in this group were Trooper Jack Rich, formerly of Culver. Members of the Alpha Delta Pi Sorority convention were also recognized. Secretary-Treasurer Peter Trone said that the Chamber totaled 82 members as of June 13.

Dr. Howard commented that a 6' x 12' billboard sign has been erected by the Chamber on U.S. Road 30 at the intersection of Rose Road, directly North of West High School, through the efforts of Chamber member Bill Stubbs of Ad-Rite Sign Co. The sign promotes the town of Culver and is readily seen by Eastward travelers, according to Ray Wickler, Sign Project Chairman.

Eddie Amoud, Chamber Publicity Co-Chairman, stated that the Chamber approved renting an office space from Kowatch Construction Co. on Lake Shore Drive and is now making final plans in staffing it with wives and volunteers.

Dr. Frank Setzler, Chamber Vice President, introduced the speaker, Mr. A. B. Williamson, Vice President of the McGill Cor-

poration, who commented on a film that explained the McGill operation. Williamson said that McGill originally began in 1965 as a prime manufacturer of electrical bearings, however, the other Bearing Divisions now comprise 75% of their total output. Culver is the site for their third factory, the first outside of Valparaiso. According to schedule, Culver should have 60 plant employees producing bearings by the first of January. McGill is proud of their precision manufacturing and boast as their slogan "Known for the Quality they keep."

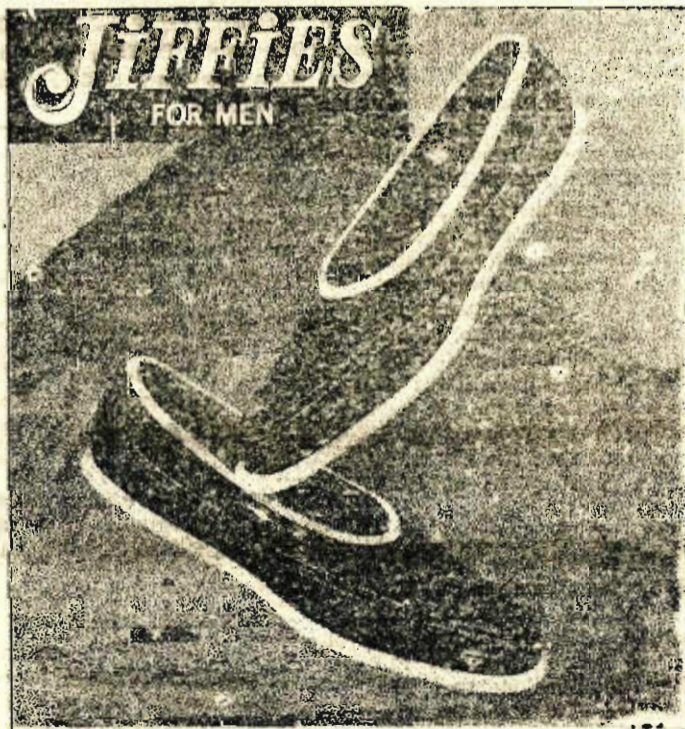

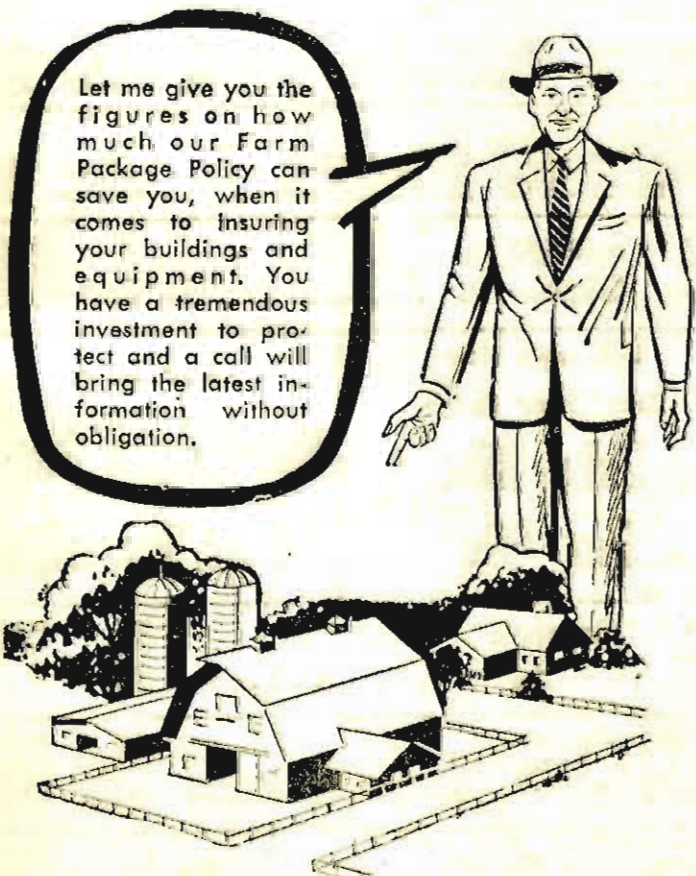

CENSUS BUREAU TO TEST U.S. SMOKING HABITS FOR HEW

Families in this area will be included in a nationwide survey of smoking habits as part of the June Current Population Survey of the Bureau of the Census, according to Director Theodore F. Olson of the Census Regional Office in Chicago.

The questions on smoking will be in addition to the monthly employment survey conducted for the Bureau of Labor Statistics, U.S. Department of Labor. Questions will be asked in selected households of 357 sample areas of the nation.

The questions on smoking, which are sponsored by the U.S. Department of Health, Education

& Welfare, will be asked of all persons 17 years old or over to determine if the person has smoked at least 100 cigarettes in his life; if he smokes cigarettes now; how many a day; if he smoked cigarettes three years ago, and if so, how many a day at that time.

Persons also will be asked if they have quit smoking cigarettes for two weeks or longer during the last three years; how many times they have stopped smoking for two weeks or longer during the last three years, and what was the longest period of absti-

nence from cigarettes during the last three years.

In addition, males will be asked about cigar and pipe smoking habits at the present and over the last three years. Information obtained from individuals by the Census Bureau is confidential by law and can be used for statistical purposes only.

Census interviewers who will collect information in this area include Mrs. Virginia Bowmar and Mrs. Dorothy Flitter.
