# Surrisi returns to Culver cuisine at two new ventures

Rumors have circulated around Culver in recent weeks that popular local chef Larry Surrisi will once again be pleasing palettes in his role as one of the community's several in-demand food gurus. This following the closing last year of the City Diner, Surrisi's most recent prior food venue. Now John Zehner, owner of two eateries here, has confirmed Surrisi will join another of Culver's chefs of renown, Greg Ogle, at two newly reformatted restaurants.

The first, The Yacht Club, replaces the Maxinkuckee Bistro as the presiding restaurant at the Culver Cove on East Jefferson Street. The Yacht Club will open April 5, and -- as evidenced at its website, www.culveryachtclub.com -- will provide seasonal dishes, "us-



ing the highest graded meats (and) produce, with a first-class wine selection." Hours of operation, according to the site, will initially be 4 to 10 p.m., Tuesday through Sunday.

"The Yacht Club will have a few higher end items," explains Zehner, "but enough moderately priced items to satisfy any budget."

Zehner describes the restaurant as "family friendly" and non-smoking, and with "a great view of the lake. The Cove did a remodel this winter and created a bunch of comfortable seating in the restaurant waiting area that also looks at the lake. You can park your boat at the Cove docks and enjoy drinks, appetizers and dinner at the Yacht Club."

Surrisi and Ogle will also be part of the Club's catering offerings, both at the Cove's banquet facilities or at customers' homes.

Rumors have also persisted as to the future of 115 East Jefferson, the site of the former Culver Cabana. Zehner says the building is still a "work in progress" but is nearly remodeled inside, and will reopen April 26 as The 115 Grill, also boasting Ogle's and Surrisi's talents.

The new restaurant (www.115grill.com) will be non-smoking, says Zehner, "with the patio and a new seating arrangement that is family friendly."

And yes, the popular, vintage school bus will still be there, but other seating, and much of the interior, will be altered from the look it sported during

## Relay `11 on track, will bring fireworks, Colts player, more

Culver's Relay for Life will return for a fourth year, and organizers -- adult and student alike -- are hoping to continue the momentum from the first three events, which surpassed many expectations to raise more than \$100,000 each year and place Culver on the map as one of the few school-hosted locations for the cancer-fighting event in the entire country. The success of past Relays has also drawn attention for the fact that much of the organizing, planning, and execution of the event is student-led. Past events have been remarkable, too, for their ability to unify the diverse communities of the area towards a common goal.

This year's Relay will kick off at 7 p.m., with the opening ceremony, Friday, April 15, at the Culver Academies football field at the intersection of State Roads 10 and 17. As in years past, the all-night event centers around fundraising teams walking laps throughout the night -- symbolic of cancer never resting -- coupled with ongoing activities and events to raise awareness about the disease, honor victims and survivors of cancer, and keep teams motivated to continue their journey.

Funds raised, as always, go to the American Cancer Society to aid in its ongoing fight against the disease and support of victims and their families.

Relay 2011 Co-Chair and Culver Academies senior Kyle Blankenship says this year's Relay is "panning out to be better than ever before!

"So far, we are doing very well number wise. At this point, we have 58 teams and over \$30,000 raised online, along with an additional \$40,000 in sponsorship. This is very good, compared to where we were at this point last year. We're hoping to keep up the momentum so that we can reach our goal of \$130,000."

And as has been the case for the past two years, a player from multiple Super Bowl winning NFL football team the Indianapolis Colts will be in town for the Relay on April 15, though as yet his name hasn't been announced.

Another new feature is the presence of Mad Bomber Firework Productions, which will add a fireworks show to the evening's entertainment.

Also as in years past, Culver Coffee Company on Lake Shore Drive is joining other local businesses in helping raise money by donating proceeds from its Drink of the Month for April to the Relay. Further, for the first two weeks of April, \$1 from every pizza purchased at the Coffee Company will also go to Relay.

This year's Relay will include the core features of years past, as well as some "to be announced" new additions. Back will be the somber but powerful luminaria lap of the event, during which lights are extinguished and luminaria bags dedicated to a cancer victim provide the only lighting through this silent lap. Area cancer survivors will once again be featured speakers during the evening, which will also include a number of themed laps. Live music will abound, as will games, food, and of course the ever-popular "Mr. Relay" portion of the evening, in which male participants are encouraged to don dresses (or feminine attire of their choosing) and outdo each other in raising funds towards the Relay goal.

#### **Culver Police release** annual crackdown results

The Culver Police Department has announced the results during the Drunk Driving. Over the Limit. Under Arrest. March crackdown.

In all, agency officers dedicated 14 hours of extra patrol towards Indiana's annual mobilization against impaired and dangerous driving. Officers stopped more than 40 motorists issuing more than 50 citations and warnings and making two arrests for Operating a Vehicle While Intoxi-

According to the National Highway Traffic Safety Administration (NHTSA), there were 103 crash fatalities on St. Patrick's Day in 2009. Of those crashes, 37 percent involved an impaired driver and/or motorcyclist with a (BAC) of .08 and higher.

Operation Pull Over Blitz 66 was supported by federal funding allocated to the Culver Police Department from the Traffic Safety division of the Indiana Criminal Justice Institute (ICJI). More than 250 Indiana law enforcement agencies participated in this annual, statewide enforcement effort, which generally occurs around the St. Patrick's Day

## Culver's Cleavenger has eye-opening county coroner report

PLYMOUTH — One thing is certain — uncertain economic times seem to have made Marshall County Coroner Bill Cleavenger a busy man. Cleavenger, a longtime Culver resident, gave his report to the Marshall County commissioners Monday and it provided evidence that his office was a busy one in the past year. Quoting statistics provided by the Indiana Coroner's Association, a county the size of Marshall

County — around 50,000 population — has approximately 500 deaths on average each year. Of those 12 percent are of a nature that they require the services of the coroner.

#### While Marshall County had only 372 deaths this past year, 102 of them required involvement of the coroner's office. Of those 102, Cleavenger's office was able to determine that 82 occurred from natural causes. Cleavenger showed the board another alarming statistic.

The county had 10 deaths with drug overdose as the determined cause — doubled from five the year before — and the county has already had four deaths due to overdose

"It has more to do with people and their impulse control than with any other cause," said Cleavenger. "Almost all of those deaths are from prescription drugs or mixing drugs with alcohol, that sort of thing.

Cleavenger said the average age of the persons who died by overdose was 34.

He also said there were seven suicides in Marshall County last year, up slightly from the year before.

One bit of good news is that Marshall County had just two fatalities from traffic accidents last year.

## If these walls could talk: 110, 112, and 114 S. Main



This week, we're stopping in at a couple of buildings today connected as one, at 110 (which includes 112) and 114 South Main Streets, where today we find The Collectors antique store (110 and 112 S. Main) and The Bear End (114 S. Main), both retail destinations operated by

This week's column has been one of the most challenging to research. Records from earlier years, and occasional tidbits from the Culver Citizen fill in the blanks for several decades, but ironically it's been some of the more recent decades, those between about 1960 and the early to mid-1980s, which have proven most difficult in pinning down which business was where. This is complicated in part by a couple of factors: first, the building to the north, 110 (and at times 112) S. Main, often was occupied simultaneously by two separate businesses. Some readers may recall one business there, but not another. Further, that stretch of commercial Culver seems to blend into a bit of a muddle for many residents, including your editor. The Wickizer building to the north -- reported on in our last column -- seems so similar to 110/112 S. Main, and the smaller building at 114 S. Main so similar to its neighbor to the north, that sorting out who was where, and when, has me a bit dizzy! Hopefully, a few readers with all the answers will contact me once this column hits the streets, to fill in the holes a bit, such as they are.

Of the two buildings in question, the northernmost (110/112 S. Main) is by far the oldest, while 114 -- the Bear End -- was erected around 1947. For many years prior, the space was a vacant lot which the late Bill Snyder, longtime proprietor of Culver's hardware store, one building south, once told me he remembered as frequently put to use for teen fistfights!

The 1906 Sanborn fire map shows 110 S. Main as a vacant lot, though by 1914's map, a tin, harness, and shoe shop was operated there by William Foss and sons. Richard Nitzchke ran a barber shop in part of what was then known

own-Frank Amond, of Maxinkuckee tour boat fame) 1947. The Culver Citizen

on October 8, 1947, reported Don purchased Grill The (which presumably means it had already operated there for a time)

and was renovating it to open the next month. Mr. and Mrs. Priest, incidentally, would open another restaurant in 1956, the Don-Marie on State Road 17 (in the building which would later become the home of Culver's Eagles lodge, and is today the Market Basket & Co.), before retiring in 1959 due to Don's health.

Verl Shaffer is one of several in Culver who recall the Grill being run by sisters Marcella White and Mildred Ditmire, when he first came to Culver in 1956. The sisters would soon thereafter open the M & M restaurant across the street 113 S. Main (site of today's Cafe Max), starting in 1959 and until 1972.

Verl says, also, that Ted Ewing and his father ran a barber shop in the basement in the late 1940s or early `50's. "Bill Davis started his barber shop in the same basement," adds Verl, "before moving in where Gail has her shop now (at 106 S. Main) in 1961.'

In March, 1958, the Citizen reported Helene Boots' opening a wallpaper and paint shop at 110 S. Main. In 1962, Awnings by Amond opened for business there as part of Gold Coast Industries, a venture involving legendary Maxinkuckee tour boat Captain Frank Amond and his son Eddie (along with a Florida-based partner), which among other things manufactured the actual awnings. These were sold and installed by way of the store front.



In June, 1983, Ron and Ruth Mackey opened The Collector's antiques and The Bear

End (bear/collectible stuffed animal store) at the site, the Collectors continuing as Culver's antique store of record, under Ruth's care following Ron's passing away. Various businesses operated at the store under the of-

ficial address of 112 S. Main, including Phyllis Zehner's beauty shop, Mary Tanguy's Mary's Shoppe (from April, 1984 to 2000), and the expansion of the Mackeys' store into its present configuration there. Three apartments occupy the upstairs of the building, having been remodeled Meanwhile, at the aforementioned former vacant lot at

114 S. Main, Duke's Jewelry and Gifts moved into the newly-built structure in November, 1947, occupying the

According to his entry in the Marshall County Sesquicentennial book, Earl Dean Overmyer opened his plumbing and heating business (the first air conditioned shop in Culver, it's noted) around 1953. While the book doesn't mention it, all evidence points to 114 S. Main as the site.

The late Earl (who died in 1995) and his wife Helen ran the business there for several years. Eldest son Lance -who of course still is involved in Overmyer Soft Water, now on Jefferson and Plymouth Streets -- came into the business in 1962. However, the business didn't stay at that site through the years. In the 1960s, Jack Spencer opened Spencer's plumbing there, a business which included natural gas delivered from his large tank on State Road 17, recalls John Sage (who would later occupy the shop) Spencer operated from 114 S. Main for years, prior to Emil "Bud" Ruhnow buying out his business in the 1970s.

Bud actually moved the operation a block south to the horseshoe-shaped building (now a parking lot) at 226 S Main, which had been Emil Senior's. According to Bud and his wife, Citizen correspondent Bobbie Washburn Ruhnow, Bud Ruhnow never operated his business out of 114 S. Main, but briefly used the store as storage for his equipment. He remembers a Plymouth-based law firm opening for business after he vacated 114, and staying there a few years before leaving the building completely vacant for a time.

In 1984, John Sage says be began renting 114 S. Main from Paul Snyder, who had owned it for years (Ruhnow

also rented it from him). Sage's Insurance occupied part of the building at the time, while Jerry Thomas operated his real estate business in the other part.

"We were in the south end of it," John Sage recalls. "All we had was a desk inside the door -- I had a behind it!"

When Realty departed in

1986, John and June Sage took over their part of the building, which they occupied until 1990, though by 1988 he says he'd purchased the former Poppe's Appliance building on Lake Shore Drive (today occupied by Dawn Minas Culver Coffee Company) in 1988, and was renovating it prior to moving Sage's Insurance there in 1990. Sage replaced a surf shop at the Lake Shore Drive site and would sell the building to Dawn circa 2006 for the coffee shop.

Jean Snyder ran Thru the Grape Vine at 114 S. Main in 1993, and Nancy Baxter briefly opened Maxinkuckee Korner the same year. The Painter & Poet Gallery, operated then as now by Esther and Ward Miller, opened in the building in the 1990s (they would later relocate to their present home and shop at 307 N. Main).



# Zeller leads Washington over CMA at state championships

INDIANAPOLIS — Not satisfied with ending a 36-year sectional championship drought, the Eagles kept on rolling to eventual regional and semistate titles.

On Saturday, their historic run came to an end as defending state champion Washington handed Culver Military Academy a 61-46 loss in the Class 3A State Basketball Final at Conseco Fieldhouse in Indianapolis.

Led by Indiana Mr. Basketball front-running candidate Cody Zeller's 20 points and 18 rebounds, the Hatchets overcame a slow start to rally past CMA in the second period, ultimately outshooting, outrebounding and generally outplaying the Eagles for a repeat 3A title and their third such championship in four years. The storied program now owns seven state titles overall, tying it with Marion for second on the IHSAA's all-time list.

"He was a big influence on this game, and that's the kind of player he is. He was able to do so many things. The thing that goes unnoticed sometimes is the way he handles the ball and can extend you out and make you guard him; he's a 6-11 guy that can put it on the floor and extend the

Washington went 22 for 43 from the floor compared to a 20-for-53 effort by CMA and enjoyed a 38-21 rebounding advantage in the contest.

Zeller, who went on to win the Arthur L. Trester Mental Attitude Award for Class 3A, led all scorers and rebounders with 20 points and 18 boards while dishing out a pair of assists with two blocks and generally creating match-up problems all over the floor. Teammates Dylan Ervin and Anthony Curtis took advantage of any double- or tripleteams thrown at the solid 6-foot-11 IU recruit with 18 and 10 points, respectively.

After trailing 7-2 in the opening two minutes, CMA went on a 16-10 run stretching from the 5:46 mark of the first period until the end of the frame to take a slight 18-17 lead at the quarter break. With 7-foot-1 Eagles center Chier Ajou and 6-5 forward Juwan Brescacin both in foul trouble, the Hatchets retook the lead just 1:18 into the second quarter on an Ervin steal at the timeline for an

uncontested layup, and Washington rolled on with a 14-6 run to grab a double-digit 35-24 halftime advantage and never trailed again.

The Hatchets held CMA to 3-for-10 shooting during the run after the Eagles' 7-for-12 start in the first frame.

"I think Dylan had a couple big keys in that stretch and that got us going," said Washington head coach Gene Miller. "Dylan's, for the last two years, been one of our best defensive basketball players and he's always making the big plays at the defensive end of the floor.

'I thought overall defensively we picked it up. After the first quarter they only scored 28 points, so I thought defensively we all stepped up."

"I would say it was a combination of our shot selection and their defense," said Galloway of the second frame Saturday. "We talk about getting good shots and we had good shots, but we needed to get better shots. That second quarter we didn't get the best shot possible. We settled for some extended jumpers when we probably should've kept attacking and then we got down and we were trying to play some zone there to weather the storm with some foul trouble. Once we took some bad shots, that allowed them to take some easy ones, and they were able to score some easy baskets in that second quarter.'

Culver cut Washington's lead back to single digits with a 6-4 mini-run to start the third capped off by a post bucket from University of Mexico recruit Ajou, but the Eagles never got closer than that 39-30 margin.

Ajou finished with 10 points for CMA, while fellow senior Brescacin tallied 12 and junior point guard Jermaine Myers scored a team-high 17 in the loss.

CMA bids goodbye to a cast of four seniors in starters Brescacin and Ajou as well as Peter Bin and Hyeong-Woo Kan. "Chier and I, we try to lead by example

on the court, but it's the guys that you don't really see - Hyeong-Woo Kan and Peter Bin —that don't really play but give us that intensity in practice and give us those looks," said Brescacin. "Those guys, they'd do anything just to step on the court, and a lot of our success has come from those guys."

Although the Eagles came up shy of their ultimate goal of a state title, they close the season with plenty of positives to reflect back on after winning CMA its first sectional, regional and semistate boys basketball championships in Galloway's first year at the helm.

"We definitely had a great season," said Myer, who passed the 1,000-point career mark for Culver back in February. "Culver's never been here before, and it

was nice to get here. We wish we would've won the game, but we fell short. This is a great group of guys. This is the best group of guys I've ever been around.

"I can't say enough about how far we've come," said Galloway. "If you had gotten to see us in our first practice, talking about being in the state championship, I wouldn't have believed it just because how hard we had to work and how far we had to come.'
