## VANDALS ENDANGER CITY Officials Issue Warning

It was reported at the Town Board meeting Monday night that an apparent act of vandalism resulted in a loss to the City Water Department of 200,000 gallons of water.

Last Thursday night, a fire hydrant was damaged on the south side of town. It was not broken at the base, which would have indicated an automobile accident, but was crushed in at the top, as though hit with a heavy hammer.

Water escaped from the hydrant from about 1:00 to 6:00 a.m. The water loss brought the main water tower level down to only 2 feet, which is an insufficient supply to put out even one local fire.

The amount of water lost, estimates Marizetta Kenney, clerk of the Water Department, is more than that used by eight households in a year.

Verl McFeely, Superintendent of the Water Department, noted at the Town Board meeting that such actions by vandals break several state laws, including those involving malicious trespass, property damage, and a possible theft of water. At residential rates, the water loss would have been billed at nearly \$200.

If there had been a fire which could not have been controlled because of the vandalism, the guilty party might also be liable for the additional damage caused by the uncontained fire.

Public officials expressed a desire that anyone who sees another tampering with fire hydrants in any way notify the police immediately, in the interest of public safety.

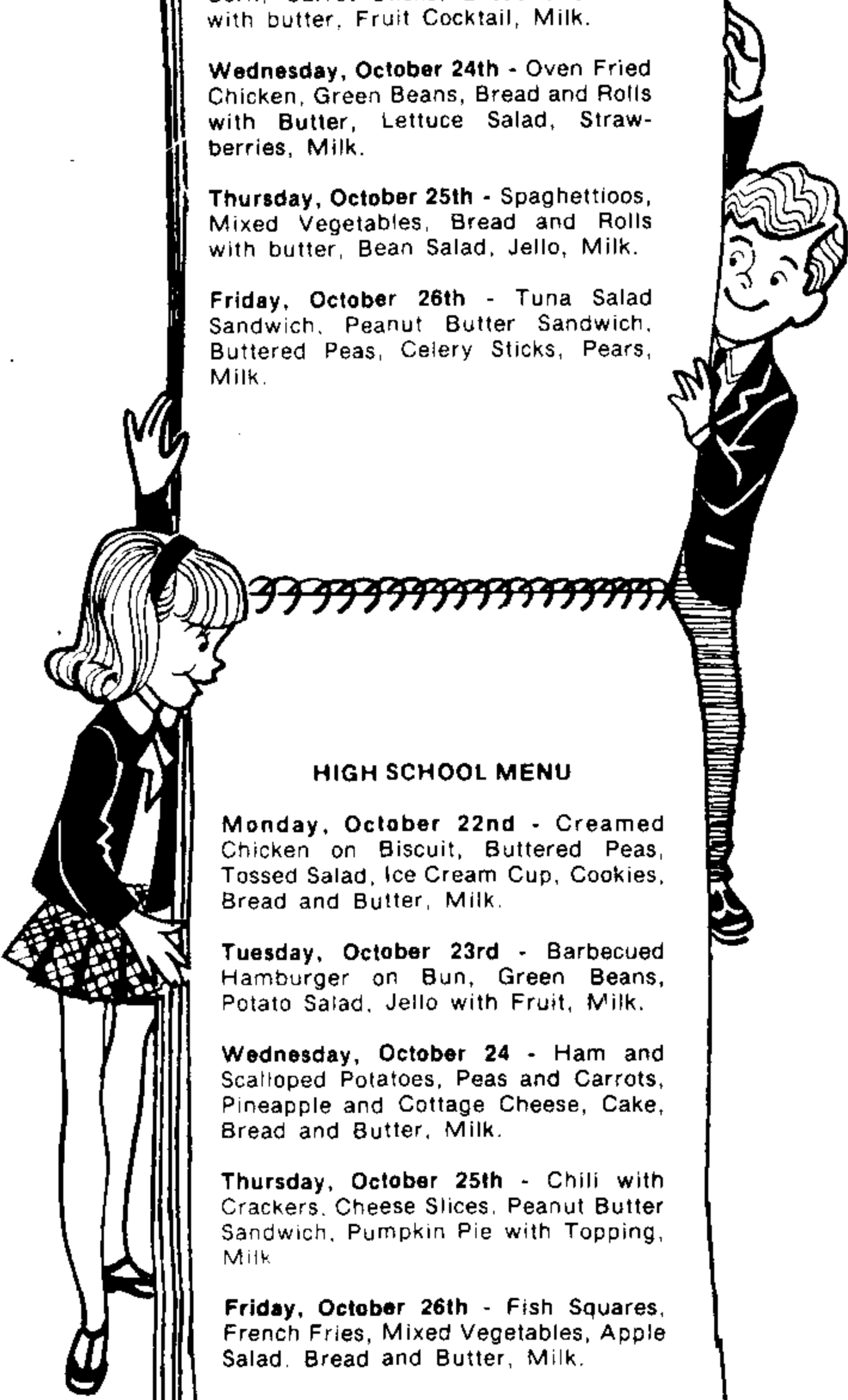

**SCHOOL CORPORATION FEDERAL GRANT**

Superintendent A.F. Allen of the Culver Community Schools has announced that the school corporation has recently received notification of approval for a Title I grant in the amount of \$16,200. This grant will cover a Teacher's Aid program for the entire corporation and provide for remedial reading services corporation-wide.

This year's grant of \$16,200 compares to last year's original grant of \$24,150. The Superintendent expressed satisfaction that the Federal Grant will allow the continuation of the services to the students in the Culver Community Schools Corporation.

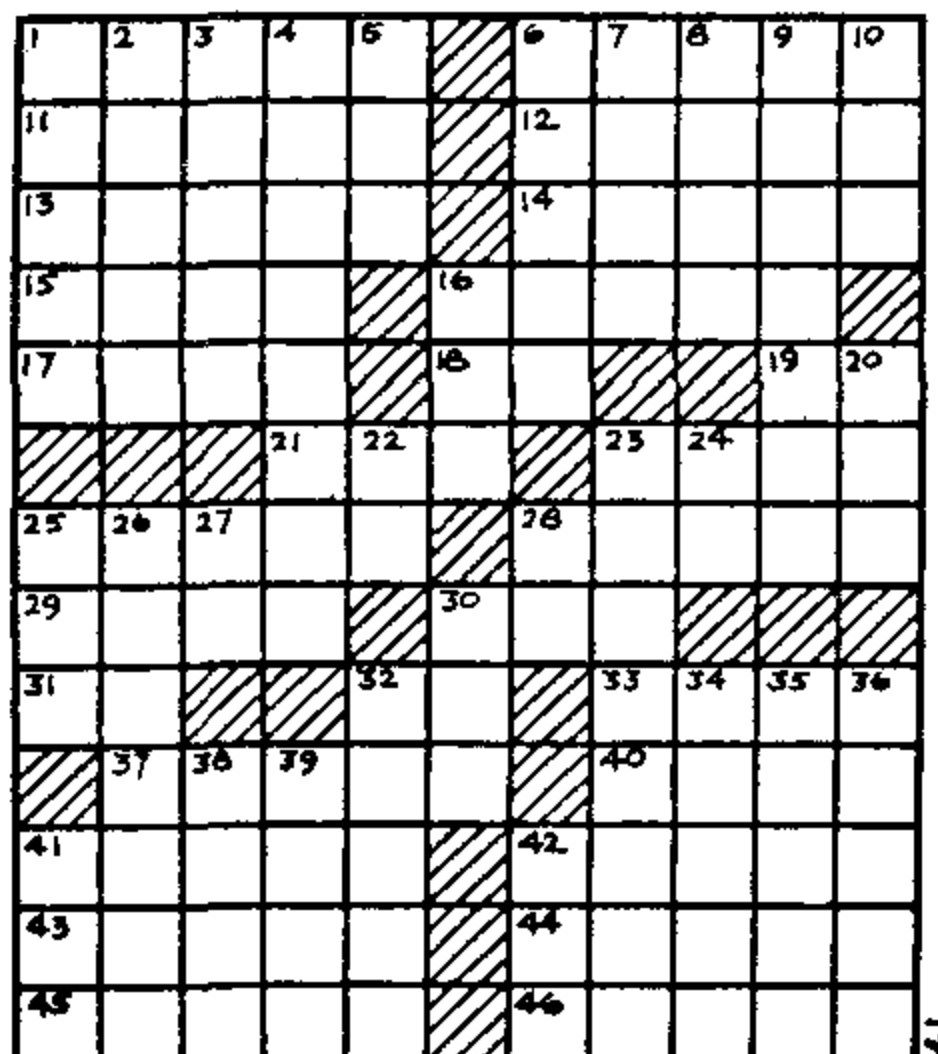

The new Girls' Dormitory on the campus of the Culver Academy for Girls and Culver Military Academy will be the scene of a housewarming October 20th as one of the highlights of the fall Festival program. The dorm is designed along the lines of a modernistic alpine ski lodge was occupied by 48 girls in September.



"Jacques Brel..."

Lives On At Eppley

An Indiana audience probably cannot be said to expect a man with a pigtail and earring to walk up to a microphone and let loose with glorious basso tones of good music. But expectations were ingored in Culver Military Academy's Eppley Auditorium last Tuesday evening as an open stage with only scanty lighting and a few musicians held a full house interested and entertained for over two hours.

The attraction was "Jacques Brel Is Alive And Well And Living In Paris".

Following a lights-up overture of sorts, the stage lights dimmed to the sounds on synthesized music created by playing conductor Bob Christianson. What followed was a staged concert that was as much theatre as music, performed by three vocalists and five instrumentalists, although roles were exchanged on several occasions during the evening.

The main vocal chores were shared between Shashi Musso, Dede Washburn, and Paul Baker. They and the others are members of THE ALIVE COMPANY, presented by Wayne Adams.

The music was created by Jacques Brel, a Belgian songwriter and performer who is less known in this country than in Europe, where his songs are widely known and very popular. The songs were all presented in English, although the translations seemed, at times, to worry too much about American cliches and less about the musical atmosphere of the songs.

The small orchestra managed to provide a good variety of styles as a result of many instrument changes and some prerecorded effects.

On the negative side of the scale, mention must be made of the younger members of the audience, who seemed so inclined to whistle at the end of each selection that we wondered whether they understood the meaning of the songs. Also, the sound system used by the company was adequate but not nearly as good as the music being produced on stage.

In sum, the performance was of high musical and theatrical quality, and represents an excellent beginning to the Concert Theatre Series of the Culver Academies.

Do You Have HOPE in GOD?

## Mother Nature's Column

VERSATILE SOYBEANS...

.... TO EAT???

It's the season for soybeans, or it could be if you learn how to prepare the beans for your family.

Good to eat, and very good for you, soybeans can be preserved for year 'round eating.

"You can prepare both green and dried soybeans for use in meat, salads, cookies, and vegetables," says Marcile Allen, Extension foods and nutrition specialist at Purdue University.

Green soybeans, Miss Allen notes, should be heated in boiling water for five minutes, cooled promptly in cold water, and then podded. The bean will come out easily when you squeeze the pod.

Boil shelled green soybeans in lightly salted water for 15 to 20 minutes. Season with bacon, table fat, or other seasoning. At this point the beans are ready for use in a favorite recipe, canning, or freezing.

"For canning, allow four to five pounds of beans in the pod for each quart jar," Miss Allen says. "Cover the washed, shelled beans with boiling water and boil three to four minutes. Pack the hot beans into jars, and cover with the pre-cooking water or fresh boiling water, leaving one inch head space."

Process the jar at once at 10 pounds pressure (240° F). Pints should be processed for 60 minutes, quarts for 70 minutes.

To freeze green soybeans, Miss Allen continues, boil the beans three to four minutes and cool promptly in cold water. Pack the beans into freezer containers, leaving one-half inch head space. Seal and freeze.

"When preparing dried soybeans, cover with twice their volume of water, and soak for eight to ten hours in the refrigerator," the specialist advises. "Allow one-third cup dry soybeans for each cup of cooked soybeans."

Simmer the beans in the soaking water in a partially covered pan for two-and-a-half to three hours or until tender. At this point, the beans can be used like navy beans.

Miss Allen suggests using cold, cooked beans in salads. Cooked dried soybeans can be seasoned with meat broth or stretched with a can of chopped meat, or use them as stuffing for green peppers or tomatoes, sandwich fillings, or patties. Soybeans can even be used in souffles and cookies!

Soybeans, the specialist adds, are a great way to vary one dish

meals while adding nutrients to your meal. She offers this recipe as an example:

### CHILE CON CARNE WITH SOYBEANS

2 cups cooked soybeans  
 1/4 pound salt pork, diced (or other fat)  
 1/4 cup chopped onions  
 1 tablespoon chili powder  
 1/2 pound ground beef OR  
 1 cup chopped canned meat  
 2 cups canned or fresh tomatoes  
 Salt to taste

Fry salt pork until crisp. Remove pork and brown onions. Add the beef, stir, and cook slowly for about 5 minutes. Add crisped pork and remaining ingredients. Heat to boiling.

# Weekend Traveler

## SECOND ANNUAL AUTUMN HARVEST WEEKEND AT GREENFIELD VILLAGE THIS WEEKEND

This Saturday and Sunday, October 20 and 21, Greenfield Village in Dearborn, Michigan comes alive with sounds of celebration and scenes from America's past at the Autumn Harvest Weekend. For the second year in a row, the Village is presenting its own recreation of the celebrations held in rural American communities a century and more ago to mark the end of harvest season.

The Weekend brings American history to life with a unique blend of authenticity, nostalgia and entertainment. Demonstrations of farm chores using antique farm machinery fill a field near the railroad station accompanied by the chugging of early gasoline engines and the hiss of steam power. More than 30 craftsmen work throughout the Village at skills essential to farm life one hundred years ago, ranging from wool dyeing and candle dipping to soap making and horseshoeing.

Visitors can recall the not-too-distant past as they encounter the barber shop quartet, complete in turn of the century attire, as they stroll the Village streets or in the myriad aromas of yesteryear — freshly threshed grain, newly sawn wood, smoke from wood fires or even the smell of fresh pop corn made on an antique popper. An Early American Square Dance Orchestra sets the mood immediately, playing their hoe-down music right at the Village entrance. An old-time German band, meanwhile, evokes its particular kind of nostalgia outside the Clinton Inn on the Village green.

The Greenfield Village Players are on hand to illustrate the kind of entertainments and diversions our great-grandparents knew and which could have been a part of harvest festivals. In the Town Hall

the Greenfield Village minstrels present a program of early American folk songs. Next door, "Doc" Bryson and his troupe recreate an old-time medicine show from the back of their gaily painted wagon to extoll the virtues of Bryson's amazing Wizard Oil. At the Lincoln Courthouse, a re-enactment of the famed Lincoln-Douglas debates of 1858 effectively brings to life the electioneering of the past. A few blocks away, a story teller, dressed in a white suit and smoking a cigar, spins Mark Twain's yarns of the Mississippi.

Horse-drawn hay wagons wend their way along the Village streets while carriages and Model T's offer rides for visitors together with the Steamboat "Suwanee" and the century-old steam locomotives "Torch Lake" and "Mason No. 1" on the Greenfield Village Railroad.

On Sunday only, the activities field will be filled with bright red fire engines for the Greenfield Village International Antique Fire Apparatus Association First Annual Fire Apparatus Muster. Beginning with a parade through the Village streets at 12:30, the Muster presents a fun-filled after-

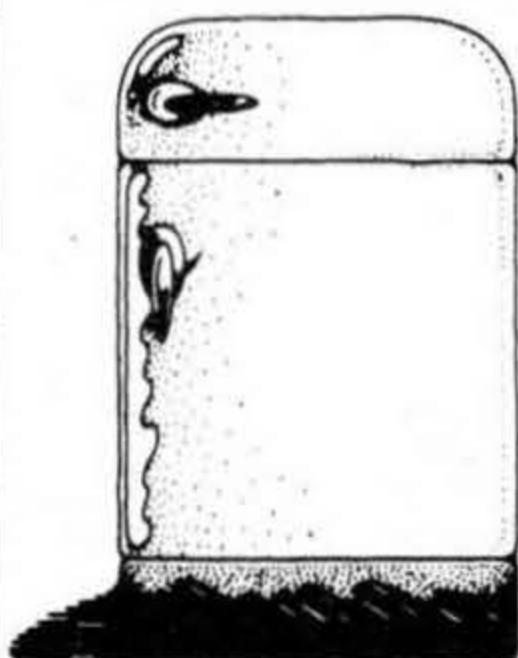
noon as more than two dozen old fire engines vie for awards and compete in a series of contests. Later they move to the Suwanee Lagoon for water pumping demonstrations. On Saturday, the activities field is the scene of a horse show with both team and individual jumping competition.

The second annual Autumn Harvest Weekend at Greenfield Village October 20 and 21, offers an authentic bit of nostalgia and a glimpse of early American rural life which has been all but lost. The activities for the Weekend are continuous from approximately 10:00 a.m. to 5:00 p.m. There is no additional charge for the event beyond the regular Village admission of \$2.25 for adults and \$1.00 for children 6 through 14. Children under six are admitted free.

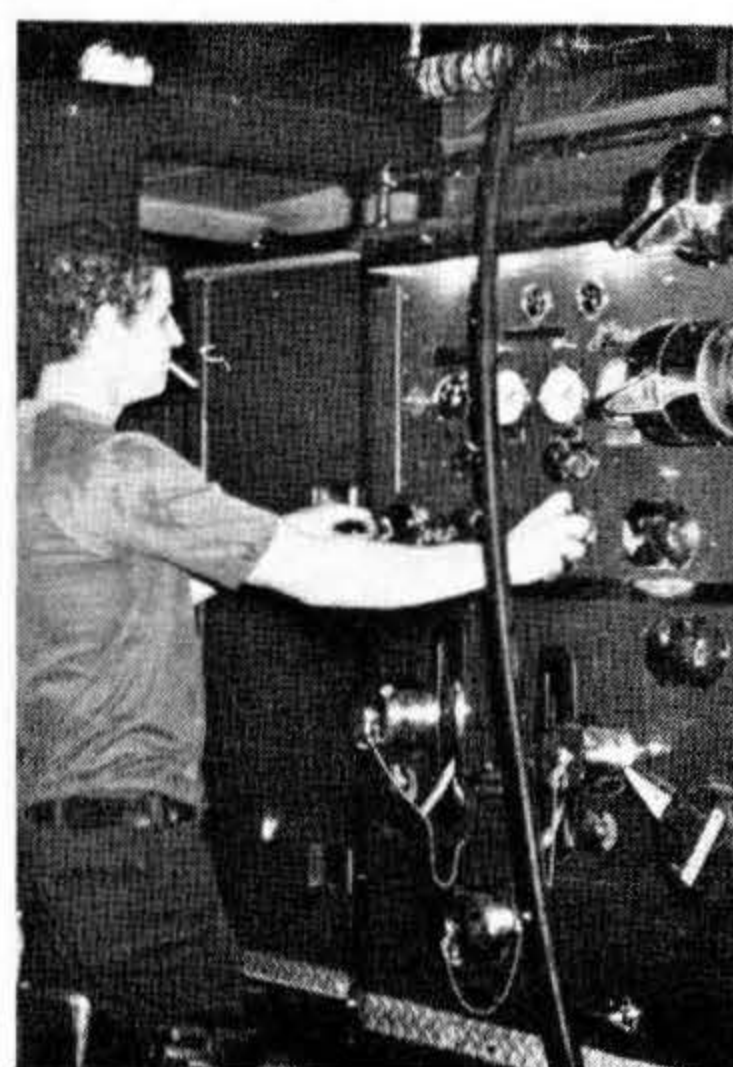
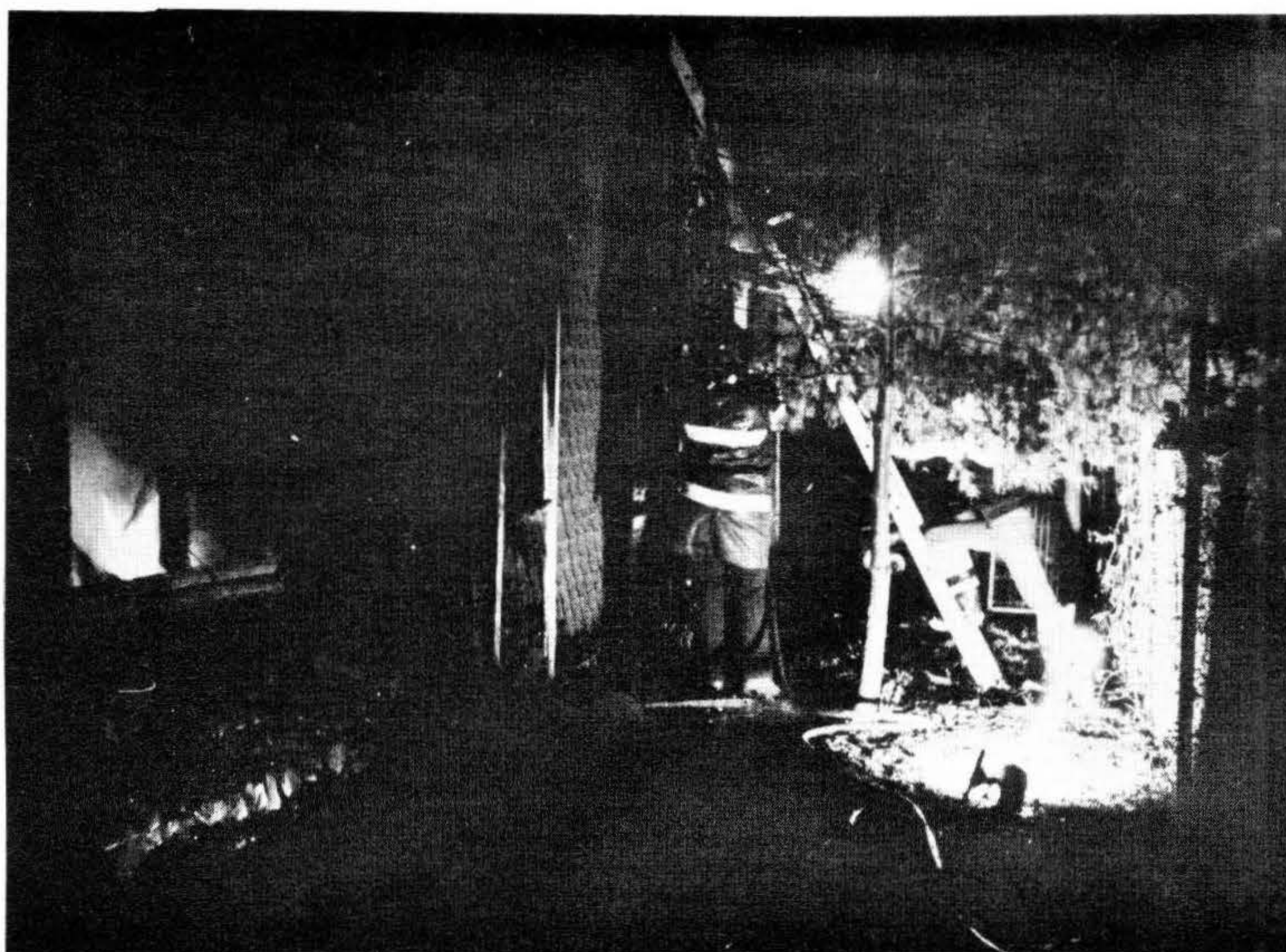



M.H. Ewald left for a tour of Kentucky, Tennessee, and Arkansas.

A barking dog saved the C.I. Ferrier home from serious damage by fire.

October 17, 1923

Claude May was re-elected president of the Culver Fall Festival and it was voted to repeat the event next year.

Miss Ann Stuprich won the "live baby" that was raffled off by the American Legion. The objections of several prominent citizens to the shocking spectacle of seeing a live baby raffled were stifled when it was discovered that the "baby" was a pig.

With 41 candidates responding to Coach Russell Burns' call for practice it is felt that the Culver High School will have a strong basketball team this year.

October 23, 1913

There was a light skim of snow on the ground Tuesday morning - the first of the season. The first snow last year was on October 24.

# The Backyard Horseman

## FOOT CARE IN THE HORSE Part I

### Everyday Care

One of the most neglected areas of horse care, particularly among inexperienced owners, is the care of the feet. Yet, the old adage "no frog, no foot - no foot, no horse" is as true today as it was when first used by someone unknown in the dim and distant past.

The value of a horse lies primarily in his ability to move in a manner that will permit him to fulfill the function for which the animal is to be used. For this reason foot care cannot be over-emphasized. In order to properly care for the foot in a horse, it is essential to have an understanding of the normal foot.

Normally, the bearing edge and hoof wall should be thick enough to withstand concussion damage. It should be resistant to dryness and have normal growth qualities. The sole should be thick enough to resist bruising and should shed normally. The bars should be well developed and the frog should be large, strong, and placed so as to evenly divide the sole with the apex pointing to the toe of the hoof wall. The important details in the care of the horse's feet are: Keep them clean, prevent them from drying, and trim them properly so they retain their proper shape and length and, if shod, it should be done properly.

Horses that are wearing shoes, or are used or stabled, should have their feet cleaned every day. Special attention should be given to the depressions between the frog and the wall. While cleaning the feet, look for loose shoes, dislocation or soreness in the sole, and thrush.

Thrush is a disease of the sole resulting mainly from failure to clean the horse's feet and keeping the animal in filthy surroundings. There is usually a black discharge and increased moisture in the frog area with a very pungent odor that is characteristic of the disease. Lameness often accompanies thrush, and if not treated, it can become serious.

Hoofs may become dry and therefore brittle. Dry hoofs can result in a loss of elasticity that may lead to the appearance of cracks in the wall and lameness. If dryness continues very long, the frog may shrivel and the heel contract.

The application of a hoof dressing to the NORMAL hoof will help retain moisture. However, the

application of a hoof dressing to a DRY hoof will prevent moisture from entering and contribute to the problem. For this reason apply hoof dressing or oils only to a normal hoof or following the application of moisture.
