Adult Education Classes Openings Remain

ADULT CLASSES MEETING AT CULVER COMMUNITY HIGH SCHOOL

The Culver Community School Corporation announces the operational curriculum for the adult education program which includes only non-credit courses. Openings exist for additional enrollees in several courses which are being taught. Most of the classes meet one night per week for ten weeks. All classes are held at the Culver Community High School.

The men's recreational physical education program meets at 8:00 p.m. EST Mondays or Tuesdays as scheduled in the high school gym. Typed schedules are available from the guidance office. No enrollment fees are charged the participants in this recreational class. Vacancies exist for new participants in the class.

The women's recreational physical education class meets on the same schedule as the men's group on the east deck of the high school gym. No fees are charged the participants in the recreational class. Additional women are invited to join this group.

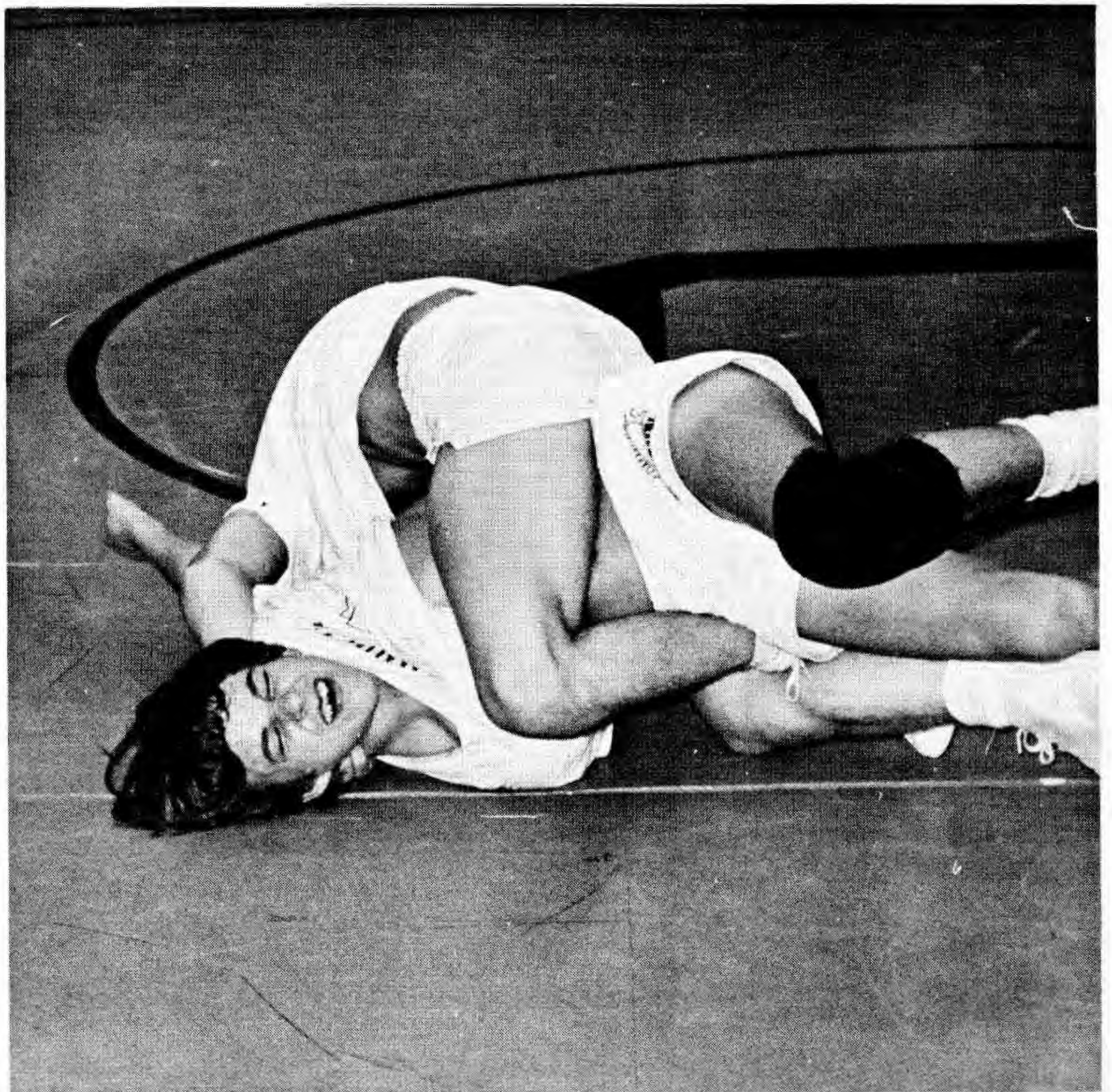

MARINE BAND TO APPEAR AT EPPLEY AUDITORIUM

The United States Marine Band, dubbed "The President's Own" by Thomas Jefferson, will appear in concert at Culver Military Academy's Eppley Auditorium on Sunday, November 4th, at 2:30 p.m.

Created by Congress in 1789, the Band made its White House debut in 1801 and has since become a featured attraction at practically all state functions. Its heritage is steeped in tradition and its annals are filled with the names of such master musicians as John Philip Sousa, who directed the Band from 1880 to 1892.

Each year 50 musicians from the Band, under the direction of Lieutenant Colonel Dale Harpham, tour an area of the country for eight weeks. The normal tour schedule is highly compact and includes performances twice daily, seven days a week. Additionally, the full band or segments of it participate in over 1,800 engagements in Washington, D.C. annually.

Wearing the traditional scarlet full dress uniform, the Marine Band will present a program designed to please practically any musical preference. The Band's library, one of the finest and most complete in the world, contains marches as well as classical and popular music and is rarely without several pieces that are particularly appropriate to the audience.

The Marine Band has developed a high degree of musical professionalism and has attracted some of the most talented musicians that the major music schools, conservatories, and colleges have produced. Its 138 members are dedicated to fulfilling the Band's mission: "To provide music for the President of the United States, the Congress of the United States and the Commandant of the Marine Corps when so directed."

Tickets for the performance are available through Harvey Firari, Culver's director of theater.

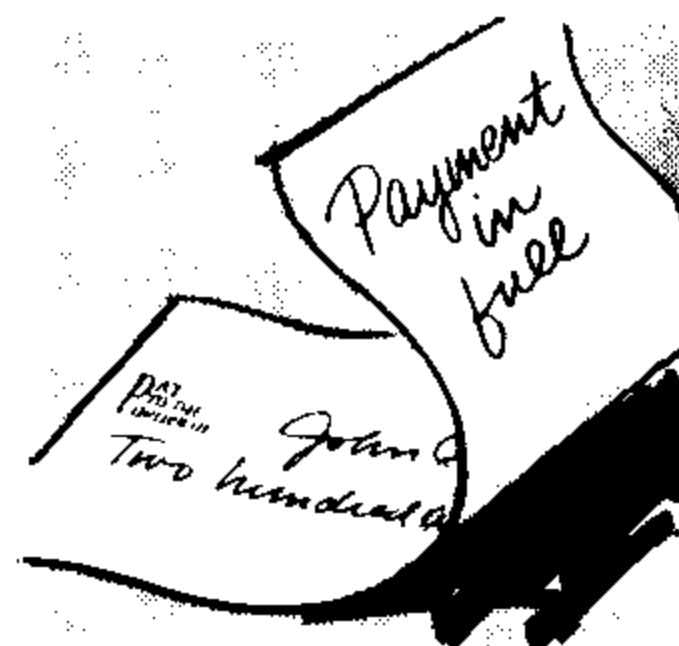
THE FAMILY LAWYER

"Payment In Full"

Suppose somebody owes you money. According to your figures, the amount is \$300. But the debtor insists that the amount is only \$200. One day you receive a check from him for \$200. On the back he has written the words: "PAYMENT IN FULL."

Should you cash the check and take a chance on collecting the extra \$100 later on? It is tempting to do just that.

The trouble is that if you cash the check as is, the law will probably consider the whole debt wiped out. The debtor has made you a legal offer to settle up for a total of \$200. By cashing the check you are accepting his offer and agreeing to a final settlement at that figure.



True, with the \$200 check in your hands, you might be reluctant indeed to let it go. One man in this predicament tried to steer a middle course. He erased the word "FULL" and substituted the word "PART," then cashed the check.

However, his strategy did not work. A court held later that he had no claim to any more money. The court said he had no authority, on his own, to alter the terms of the defendant's offer.

Another man tried something else. He too cashed a PAYMENT IN FULL check, but at the same time wrote the debtor that he simply was not accepting it as a full settlement.

But again, a court ruled that the entire debt was wiped out. The court said the man's actions in cashing the check spoke louder than his words of disavowal.

Even if you don't cash the check but merely hang onto it, you might be held to have accepted the debtor's offer. Silence can mean consent.

However, that wouldn't happen right away. In one case, a creditor kept such a check for six weeks before mailing it back to the debtor. The latter thereupon insisted that the delay had

cancelled the entire debt.

But a court decided the debt was still due and payable. The court thought six weeks was not an unreasonable time, under the circumstances, for the creditor to weigh his next move.

October 30, 1963

Basketball Open House for the Culver Community Schools will be held Tuesday, November 5, at 7:00 p.m. at the High School Gym.

A report on information regarding the use of a survey team from Purdue University and a discussion of the State School Reorganization Commission's plan to talk with the Marshall and Starke County Reorganization Committees about North Bend Township were the main items of business at last evening's meeting of the Culver Community School Board.

Local Boy Scout Troop 290 is inviting all boys of Culver, between the ages of 10½ and 12 years, to join them this Saturday, November 2, for a hike, pioneer dinner, games, contests, and a deer roast.

The Culver Fire Department was called to the lake side cottage of Robert D. Robinson, 1322 East Shore Drive Sunday evening about 5:30 p.m. to extinguish a burning pile of old lumber. Origin of the blaze is not known.

October 28, 1953

The third report of the Culver Methodist Church Building Fund reveals that 95 per cent of the pledges total \$110,000 toward the construction of a new house of worship that will shortly replace the present 55-year-old Main Street landmark where the Rev. Dr. Harry W. Campbell is pastor.

Edwin W. Dybing of Cape Cod, Massachusetts, has taken over the management of the Maxinkuckee Inn.

The annual Culver Carnival will be staged Friday evening by the Culver schools and the American Legion.

November 3, 1943

When W. S. Easterday locked his funeral home Sunday night, the click of the key marked the rounding out of 50 years of continuous business in Culver.

A total of 2,801 war ration books No. 4 have been issued.

Kenneth H. Kemple graduated with a 93.6 average to become honor man in a class of gunner's mates in service school at Great Lakes, Illinois.

Town trustees elected were Clyde Shively, Conrad Mattox, and Frank McLane. William R. Easterday was selected as clerk-treasurer.

William Taber graduated as mess sergeant from the School for Cooks and Bakers at Camp Beale, California.

November 1, 1933

N.W. Rector received a cut on the back of his head when he fell off a stepladder and hit his head on a magazine rack.

Culver High School will open its season against Bourbon with Kendall and Mikesell at guard; Scruggs at center; and Lindahl, Rich, Staddon, and Babcock fighting it out for the forward jobs. Osborn, Porcher, Burch and Waite are the reserves.

Reduction of electric rates in Culver has been announced by the Northern Indiana Public Service Co. The reduction represents a cut of 7.2 per cent.

October 31, 1923

M.H. Ewald has enlarged the facilities of the City Meat Market to give room for curing and cutting meat.

The Town Board has decided to open the south end of Ohio Street. It now ends at Mill Street. The corner of the

south end of Main Street will be enlarged as a number of accidents have occurred at the sharp turn.

Mrs. Elizabeth Hubbell writes from Grenoble, France, that she is enjoying the citizen each week.

At the senior class Halloween party prizes for best costumes went to Palmer Whitted, Verda Romig, Helen Wills, and John Servies.

GEORGE ROGERS CLARK FEATURED ON BICENTENNIAL MEDALLION

Who was the foremost hero of Indiana history?

For the entire history of the Hoosier State, an absolute answer would be difficult. But for the American Revolutionary War period as it involved the Indiana area of the Northwest Territory, the answer might be agreed to quickly.

That hero was a courageous young man who led daring military exploits from 1774 to 1779 in what is now America's Midwest - George Rogers Clark. Clark was but 26 years old when his bold strategy brought about the capture of Fort Sackville at Vincennes from the British in 1779.

Thus, it is appropriate that Clark's profile is featured on Indiana's official medallion recognizing the 200th anniversary of the American Revolution. The issuance of the art medal is the first of several public events planned by the Indiana American Revolution Bicentennial Commission.

The Indiana bicentennial art medal went on sale October 1st in participating member banks of the Indiana Bankers Association. The institutions are handling the sales on a non-profit, community-service basis, and proceeds will help underwrite other bicentennial programs.

It is available in silver or bronze in two sizes. The 2½-inch silver version is serially numbered and sells for \$45.00 each, and is limited to 2,500 pieces. A silver medal of 1½ inches costs \$12.50 each. A 2½-inch medal of classic bronze costs \$6.00 each, and a 1½-inch medal of antique bronze \$2.50 each.

Hector Garcia, associate professor of sculpture at the Fort Wayne Art Institute who designed the medal, said he attempted to recapture Clark as he looked as a young man of 26 in his portrait. It shows Clark with a head of hair reaching his collar top, a style common for frontiersmen of that period, Garcia said. It was Clark's capture of the British settlement at Vincennes in 1779 which opened up the entire Northwest territories for the new nation.

Clark was the founder of Clarksville, where he and several of his men lived for a number of years. He died at the age of 66, and

was buried in Louisville. Clark and his men were granted 150,000 acres of land on the north side of the Ohio River opposite Louisville. He never was paid several thousand dollars owed him by Virginia. He often bitterly stated he had gained the nation half its total area and "they suffered him to go in want."

The medal program is among activities of the Indiana American Revolution Bicentennial Commission designed to promote public appreciation of the state's heritage and the founding of the nation. Commission chairman is former Governor Roger D. Branigin of Lafayette, and chairman of its medallion committee is Mrs. James B. (Dolores) Dean of Valparaiso.

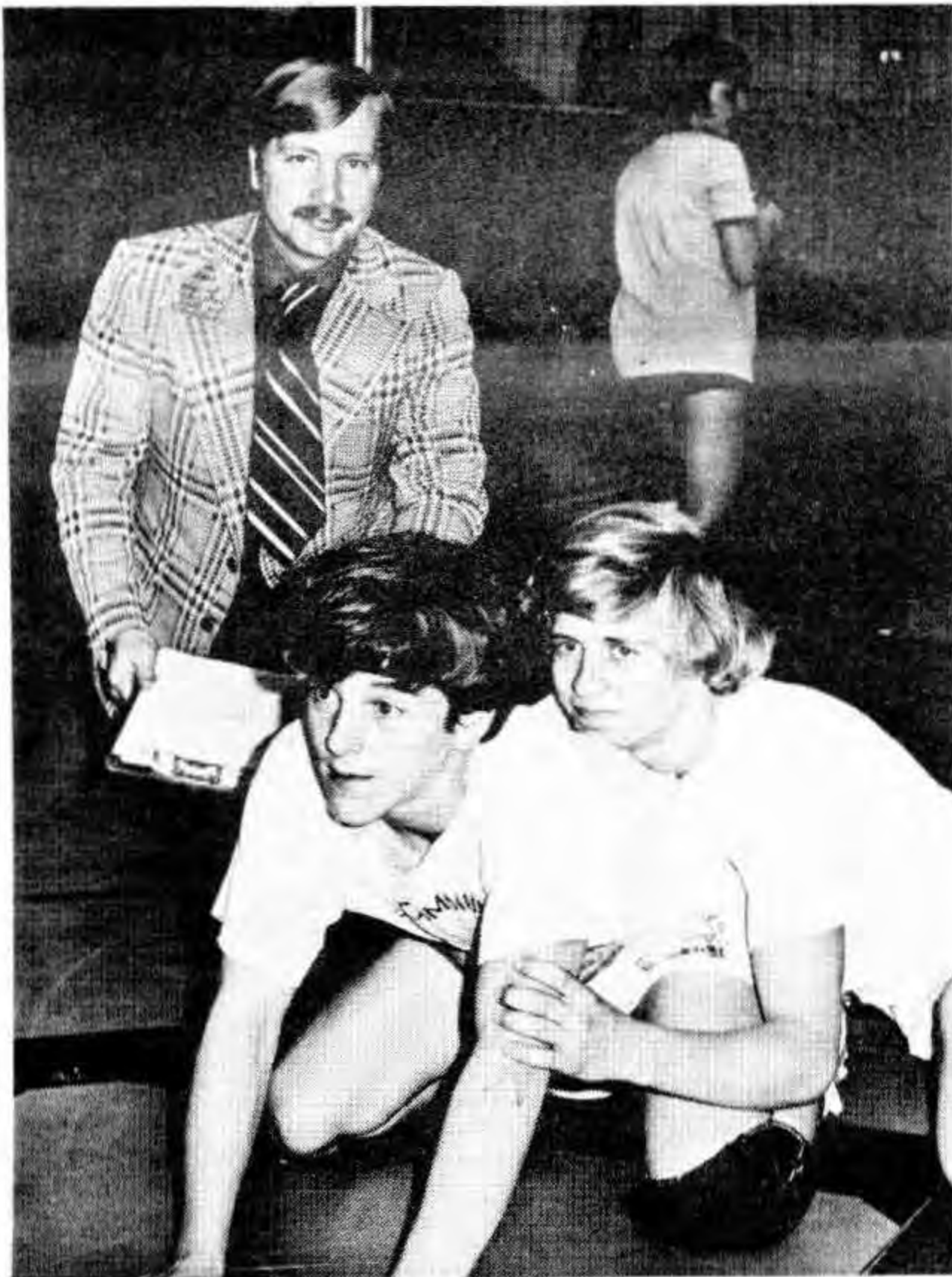

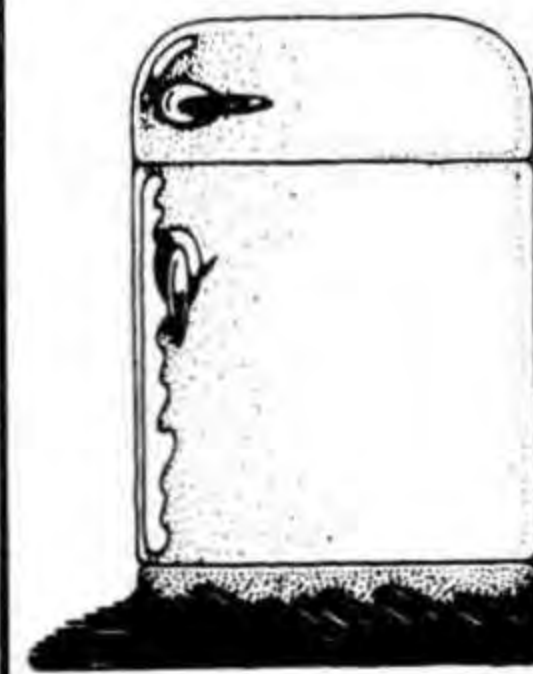

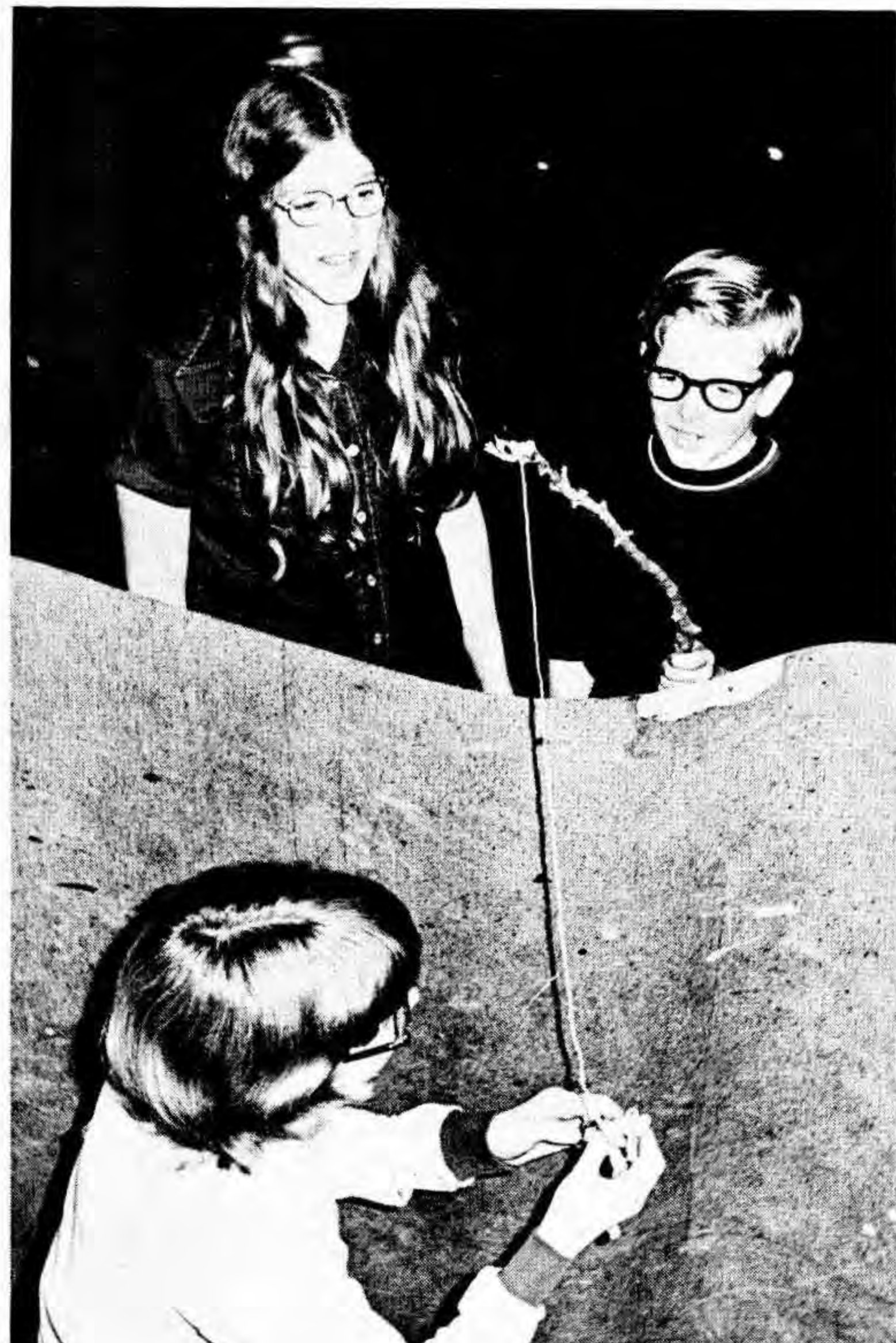
