School Board

THEY DID IT AGAIN...

Imagine, if you can, the School Board publishing the following notice:

TO CONCERNED TAXPAYERS, PARENTS, TEACHERS AND STUDENTS: We, the School Board, invite you to a special meeting of the Board which will be held to learn the public feelings about the proposed renewal of employment contracts of the Superintendent, the High School Principal, the Junior High Principal, and other top administrative personnel."

Of course, this notice is only imaginary, because our School Board does not operate in such a fashion.

Several weeks ago an editorial in this newspaper decried the way the Board handled the extension of the Superintendent's employment contract without publicity of any sort.

Following the appearance of that editorial, we requested in writing to the Superintendent a copy of all Board meeting agendas in advance, so that ample publicity could be given to important subjects scheduled for consideration. We were notified by the Superintendent that this was impossible, since often the agenda was prepared at the last minute just before meetings.

Well, the School Board last week renewed the employment contracts of all principals and assistant

principals in the school system, again without publicity, and again without the slightest hint that the Board even cared what the public thought of these contract extensions.

It may be that, after such a public hearing and due deliberation, all of these contracts would still have been renewed, and we do not mean to suggest that we now lack the high quality administrative talent this school system needs and deserves.

But, we do suggest that the present School Board procedure does not allow the public to contribute opinions and information in a formal way. Without such input we cannot consider the Board's actions to be based upon adequate information. Without changes in the way such important actions are taken, we wonder whether Board members are really representing their community.

These contracts concerned some thousands of dollars, and the quality of education that is affecting hundreds of children in the school system. The subject deserved more consideration from the Board than it apparently received, and the almost offhand treatment should be remedied by scheduling a public meeting before the Board's action of last week is formalized in writing.

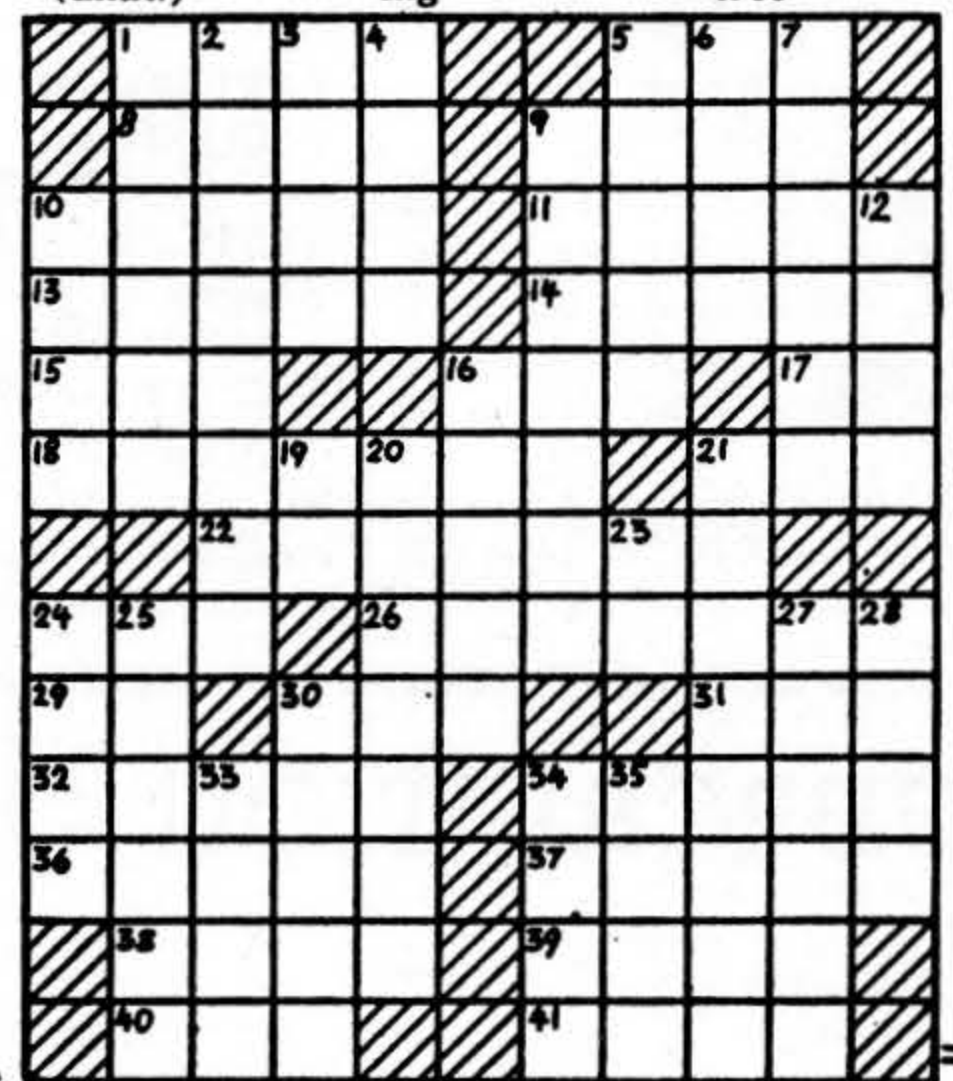

Official Resume Of School Board Meeting

February 5, 1974

Issued By Superintendent's Office

Members of the Culver community schools board of trustees this week heard two concerned Bass Lake area parents ask about the possibility of having driver education courses during the regular school term to eliminate some of the excessive driving necessary for a summer program. Board members replied it would be "very difficult" to schedule classes for the number of students involved.

However, board members will consider the possibility of setting up a pickup point for students for the driving part of the program, but parents would still be responsible for getting students to and from school for the classroom part of the course.

In other business, the board authorized the high school athletic department to purchase a weight training station to make that department more complete to better serve the needs of the students.

After hearing of a need for an assistant baseball coach for the spring and summer baseball season, the board decided that Ron Anderson, from the high school physical education department, will serve in that capacity for the spring and summer season.

Approval was given for a junior high school wrestling program for the corporation, to be directed by Anderson. The program will run four nights a week for three weeks. Wrestling will begin Monday, February 18th, and will continue through Friday, March 8th.

The board approved installation of a second telephone line at the elementary-junior high school building to help handle the load of incoming and outgoing calls. Palmer Leonard was appointed a member of the Monterey and Tippecanoe township public library board, with his term of office to expire October 7, 1977.

Superintendent A.F. Allen was

authorized by the board to attend the school administrator conference at Atlantic City this month.

Following a discussion, the board unanimously approved extending a new two year contract to each principal and assistant principal of the school corporation.

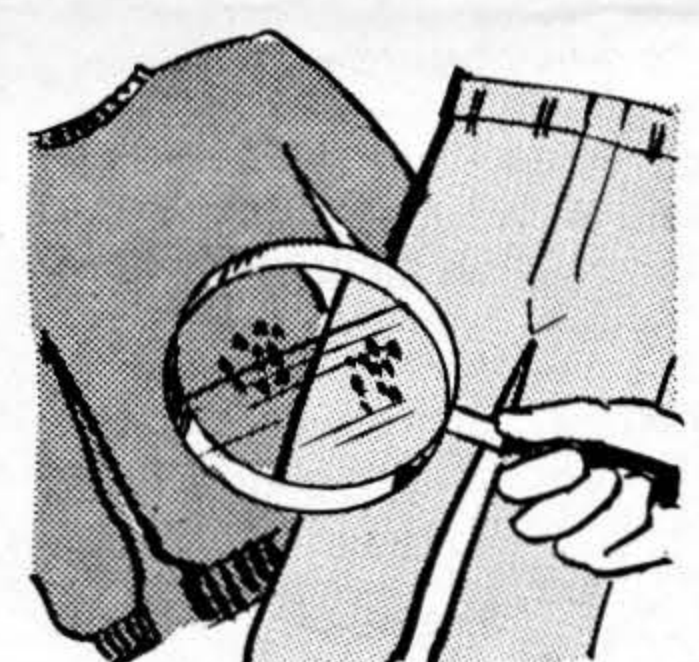


Telltale Gamma Rays

Police scientists, working on an assault case, checked the gamma rays emanating from a bit of dirt taken from the victim's sweater. Then they checked the gamma rays from dirt on the suspect's trousers.

The rays matched—and the evidence later helped to send the man to prison.

The case illustrates a potent new weapon ("neutron activation analysis") in the fight against crime. Gamma rays, under proper conditions, can reveal whether any two objects—no matter how small—came from the same source. The gamma rays are brought into action by "charging" the objects with radioactivity.



Already, the method has been used to track down the source of everything from paint to pipe fittings, from oats to heroin, from hair to moonshine.

Nevertheless, like any new technique, it must be used with appropriate caution in order to qualify the findings as legal evidence.

Thus, in a murder case, comparisons of blood made with gamma rays were held not admissible because technical difficulties made these particular tests less than convincing. The court warned against "the misleading aura of certainty which often envelopes a new scientific process."

In one unusual case a taxpayer, claiming a refund from the government, staked everything on a scribbled notation in the margin of his checkbook. The government retorted that he might easily have inserted the notation years after the date of the original entries.

To settle the matter, scientists compared gamma rays from the ink in the notation with gamma rays from the ink in the regular entries. The similarity of the rays convinced the government that the taxpayer was indeed telling the truth.

Result: he collected his refund in full.

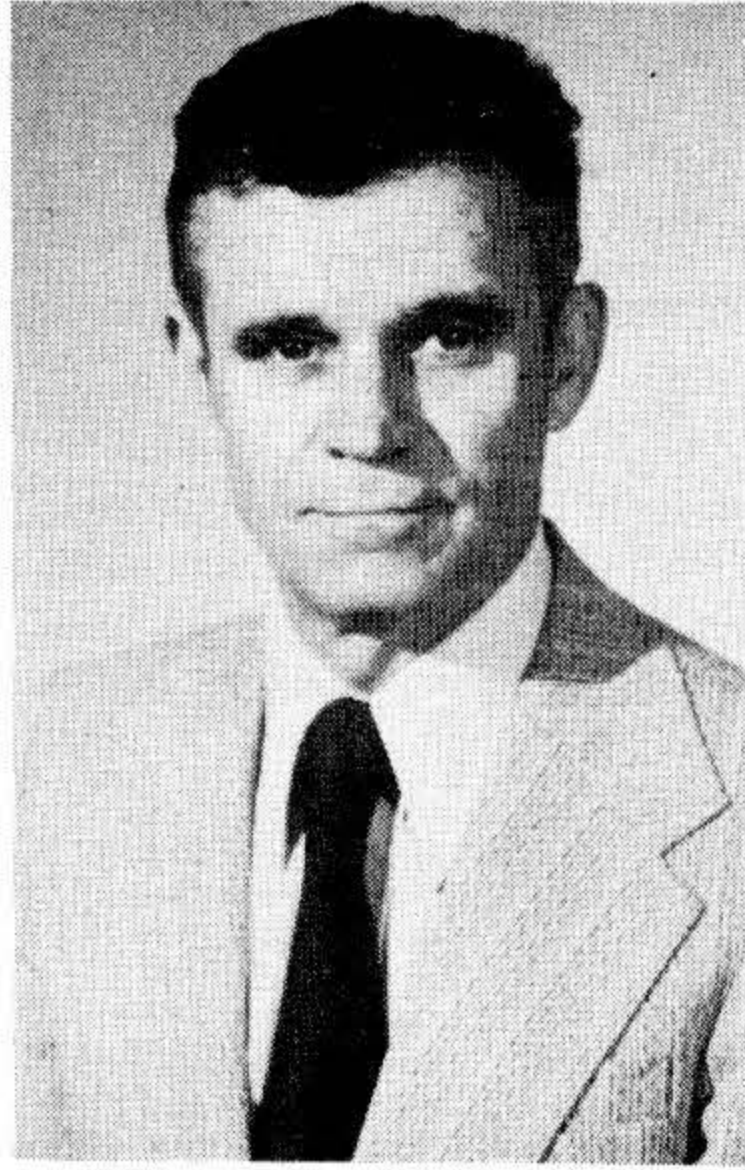
Rodda's public relations responsibilities at Culver include writing for Culver's publications, preparing news released and feature stories, and establishing media relations.

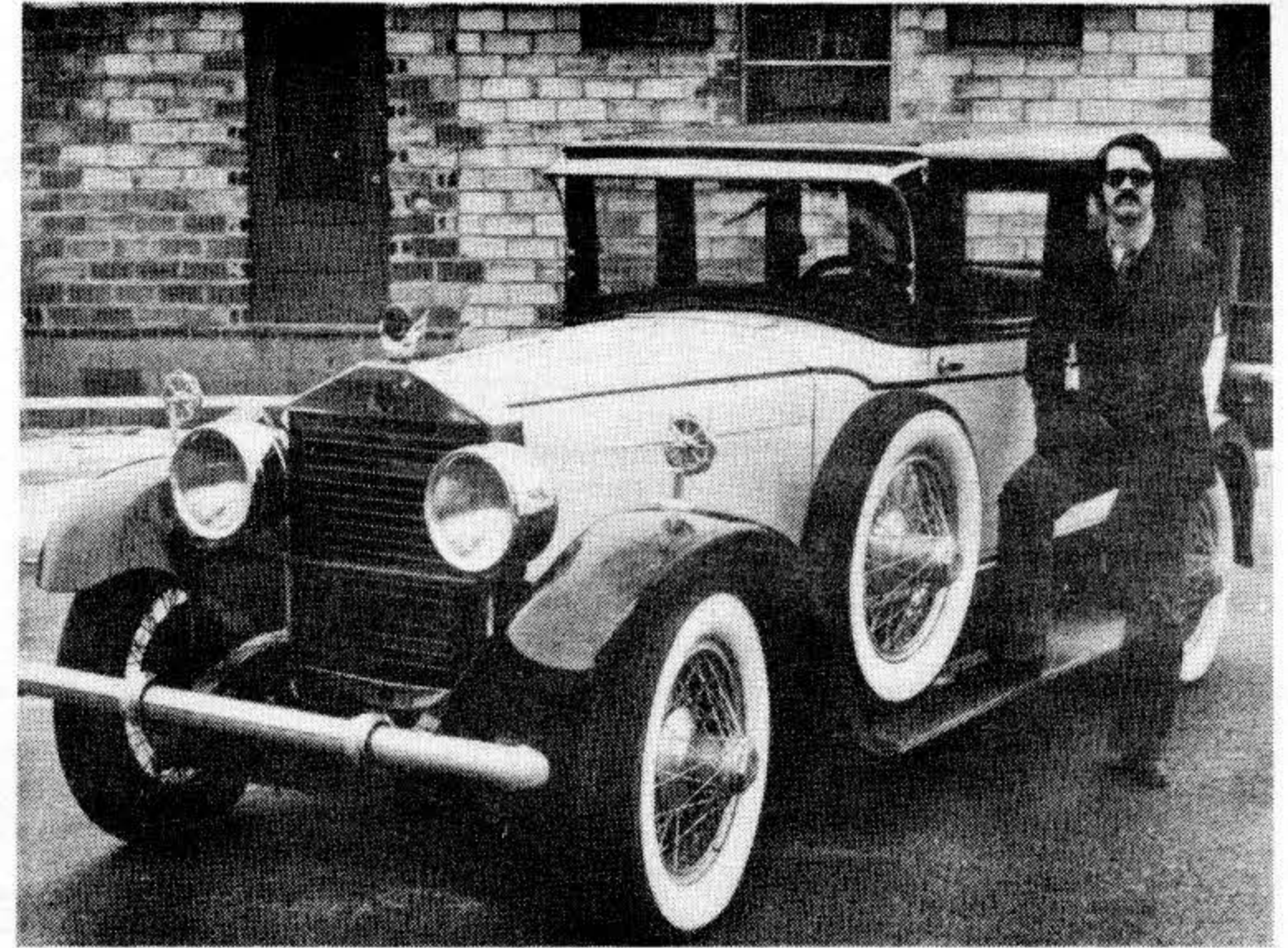
